Highlights--Monthly Meeting for Business--January 17, 2010

Holly Baldwin's transfer has been accepted by Fresh Pond Meeting in Massachusetts.

Paul Diamond gave a mid-year **Treasurer's Report**, which indicated that both expenses and contributions are in good order.

Ministry & Counsel has been discussing ways in which to enhance the spiritual health of the Meeting. One major endeavor will be the QUAKER QUEST session to be held after potluck on February 7th.

There will be no arrangement to "call off" meeting for worship on a stormy Sunday; instead the front door key will be accessible for anyone who can make it to the meetinghouse.

Meetinghouse & Grounds has ordered new thermostats for the heating system.

Pastoral Care--Annie Grace and David Cadbury have both had major operations. Viki Diamond will have surgery on Thursday, January 21. Alice Lacy is in a care facility in Boothbay Harbor.

Religious Education--It was agreed to read aloud folktales from *Earth Care* during our potluck meals starting on February 7. It was also approved that children be in meeting for worship on Sundays for the first fifteen minutes but, with rare exceptions, will not re-enter before the rise of meeting.

Gifts & Leadings--Working with the text "Discerning Jobs Essential to the Meeting," the seven points put forward were each discussed. It was agreed to gather twice each year (April and October) to discuss the health of the Meeting with regards to such concerns as outreach, service, and education.

Each monthly meeting for business will **highlight one committee** and its mission for in-depth discussion. Any committee with a pending decision or information to impart will also be on the agenda.

The Meeting Handbook will be revised and re-issued when the committee discussions are completed.

Ministry & Counsel will give greater attention to newcomers and attenders, along with their continuing concern for vocal and silent ministry in the meeting.

The **Peace Center** Board is exploring service projects that might engage the whole Meeting.

A list of "**Resource People**" in the Meeting has already been issued [*Ed. note: see January newsletter*].

New Business

- It was agreed to purchase a new DVD player.
- A solicitation of funds for relief work in Haiti (including the proceeds of the Christmas Bazaar) to be sent to Doctors Without Borders came to a total of \$1,000.
- At the rise of meeting on March 14, Jim Matlack will lead a priority-sorting discussion to arrive at a short list of "Legislative Priorities" to recommend to Friends Committee on National Legislation.

The **next meeting for business will take place Sunday, February 21**, at the rise of meeting for worship. All are welcome. Please bring a bag lunch. THOUGHTS FROM THE ARCHIVES

In going over old Meeting papers, I came across this game or exercise that a group of members of our Meeting did together many years ago (before my time, and we've lived here 22 years!). It was amazing to read and I think valuable to share with everyone. It is very thoughtful and may lead us to prayerful consideration today.

Game: We're all in a lifeboat, shipwrecked (about to die probably). Each of us is to write in the next five minutes a statement of his own personal belief - one point (at least), the essential. Do not sign it. We will then exchange and discuss.

Written Answers:

1. There is power in love. Our death here together may in itself spark (the) life (of the spirit). This moment, like each we have experienced in our lives, contains potential eternity. As we are aware of it contributing our loving response to it, we contribute to the meaning in the creation.
2. A belief is one thing; and an experience is something else. A belief becomes an intellectual concept that in religious terms becomes theology and dogma. An experience is recognition of the spirit within man – as the feeling for Jesus of Christians and particularly
3. I believe that God is revealed to us through the power of love--that this force of love is the force of Life. It is timeless and eternal. It exists forever.
4. I believe in: Seeing God first in all circumstances. Love thy neighbor as thyself in all circumstances. The redemptive power of the living spirit of Jesus,
5. I believe in another spiritual discussion, which George Fox experienced and which also coincides with everything Jesus taught. There is a supreme Spirit, call it what you will, which is guiding the universe.
6. Faced with Death – I believe I would continue as I have – to feel death is a part of Life – an extension and/or new experience and holds no terror. I could feel this way because of the belief of that of God in every man and so I am a part of the ultimate Pattern whatever that may be. (Is this another interpretation of the Resurrection??)
7. It is man's way to teach. It is God's way to experience. Teachings are merely the substance of other men's thoughts and experience fossilized into beliefs or creeds. They are tradition made law. My only belief is that man can transcend his physical life through his spiritual life.
8. I believe that there is one absolute Truth toward which the human race seems to have been moving, and toward which we must continue to move if we are to survive. The sense of what this Truth is available to everyone if they will listen to it and not to the voice of Death.
9. George Fox said, "Christ has come to teach his people himself." This he knew experimentally– I believe we have to know God thru experience. This, to me, is what Jesus tried to teach his people and this is what I am trying to live. The New Testament is revolutionary and few of us have dared to live by it. The power of the living Christ is all I need. To experience the Spirit of God. All I need is to live with Faith – Faith in constant change, constant growth, which will help me become a Christian.

ADVICES--The Spiritual Life

Take heed, dear Friends, to the promptings of love and truth in your hearts, which are the leadings of the Holy Spirit. It is God's redemptive love that draws us, a love shown forth by Jesus in all his life, on the cross, and in his abiding presence.

Friends are advised to make a quiet place in their daily lives for prayer and communion with God and to be constant in the reading of the Bible and other devotional literature.

Let us cherish the seed of God in ourselves and in others, that we may be open to new revelations of truth. Let us look to our meetings to guide and stimulate our spiritual growth.

"Seth Singleton holds degrees from Harvard and Yale. He was a Fulbright Scholar in Vietnam and Bolivia, has taught in Tanzania, Russia, Ecuador, and Mongolia, and has been academic dean of universities in the United States and abroad. Among other assignments, he helped Russian colleagues to remake the Higher School of the Communist Party in Leningrad into the Russian government's public administration school (1991-92) and was founding academic head of a new university in Ecuador. He now teaches international relations at the University of Maine at Orono and serves on the Board of Directors of the Camden Conference."

Directions: The Hulls Cove Tool Barn can be difficult to find for first time visitors to Mount Desert Island. When driving onto Mt. Desert Island, be sure to bear left on Rt. 3 just beyond the Thompson Island Information Center. Hulls Cove is just prior to the main entrance to Acadia National Park on Route 3, three miles north of (before) Bar Harbor as well as 16 miles south of (beyond) Ellsworth.

As you enter Hulls Cove you will see on your left the ocean and the Chart Room Restaurant. On your right will be the Hulls Cove General Store, Dysart's Station and Post Office. Turn right at the Dysart's sign. After the pumps, the Breakneck Road goes diagonally up a small rise. Look for the large wooden sign for the Tool Barn and Davistown Museum. You will notice the Sculpture Gardens on your left and the red farmhouse on your right at the top of the rise. The Tool Barn is located beside the house. You will be welcomed at the kitchen door of the red farmhouse.

If you pass the turn, just prior to the Acadia National Park Entrance you'll see a small sign directing you back. GPS USERS, PLEASE NOTE: You must enter "Bar Harbor 04609" instead of "Hulls Cove 04644".

QUERIES--The Spiritual Life

Do you live in thankful awareness of God's constant presence in your life? Are you sensitive and obedient to leadings of the Holy Spirit? Do you seek to follow Jesus, who shows us the way? Do you nurture your spiritual life with prayer and silent waiting and with regular study of the Bible and other devotional literature?

Clerk Deb Haviland submitted the following, which she thought might be helpful to any Friend clerking a committee:

Practical Hints for Clerks (from the Atlanta Friends Meeting newsletter)

The following list was derived from suggestions made at the FGC Ministry and Nurture consultation for yearly meeting clerks in 2005. It is offered here for monthly meetings in the spirit of viewing all clerking as ministry, whether for a monthly or yearly meeting committee:

- Ask one or two Friends to hold the meeting in prayer during meeting for worship to attend to business. If a committee is experiencing difficulty, a committee clerk may also request a prayerful presence during the committee meeting(s).
- If needed, invite Friends to return to Silence to help find the sense of meeting.
- Be aware of teachable moments.
- Have phrases you can use in needed moments - some clerks bring meaningful phrases with them that they can turn to as needed.
- Be aware of where you are on any given concern brought before the meeting and stand aside if you are too involved to be able to clerk a particular piece. (This should not happen too often.) This includes moving physically away from the clerks' table for all discussion of the concern through the minuting of an action. The assistant or recording clerk usually serves as clerk during that time.
- Remember that clerks don't have the answers - our work is to help discern the sense of the meeting.
- Remember that you don't have to call on everyone whose hand is raised. The person called on may have spoken to others' concerns as well. Calling on everyone can serve to encourage Friends to repeat themselves and carry on discussion well after the clerk has come to clarity of the sense of the meeting.
- If many have spoken the clerk may ask a person whose hand is up if this is something new or if he/she is affirming what has already been said. This helps Friends come to understand that they have reached a sense of the meeting and that it is time to form a minute.
- Things the assistant clerk can help with include: helping clerks find clarity; serving as clerk if the clerk needs to stand aside or be absent from a session; honing a difficult minute; helping the clerk keep tabs of physical energy in the meeting...stretch breaks etc.
- When facing a problem of too little time and too many agenda items, the meeting can help make the decision of what to leave out and how best to use their remaining time.

Pray without ceasing - we are servants of God.

American Friends Service Committee in Haiti

The American Friends Service Committee's assessment team in Haiti reports that while the situation is calm, needs are great. Many in Haiti are now homeless, living in temporary camps or sleeping in the streets. In Haiti, AFSC has granted \$50,000 to provide 10,000 meals for 100 days and another \$50,000 to transport medical supplies and provide emergency shelter materials for medical teams. The Service Committee is thankful for the generous contributions from thousands of Friends and others and is in the process of determining a longer-term plan that supports a Haitian-led recovery.
