## Highlights

Meeting for Business, Fifth Month 18, 2008

**Finance Committee**--The Meeting considered the final draft budget for 2008-09. Committee budgets will be cut as well as the budget for contributing to "worthy needs." An ad hoc committee comprised of Karen Cadbury, Carmen Lavertu, and Linda Cote-Small was formed to consider alternatives for funding worthy needs.

**Ministry & Counsel**--Friends **approved** with pleasure the committee's recommendation that Thomas Steele-Maley's application for membership be accepted. There was discussion regarding how the Meeting will respond to the request from NEYM (New England Yearly Meeting) for input regarding same-sex marriages under the care of a meeting. Ministry & Counsel will consider today's remarks. They will review last fall's minute approved by NEYM, Vassalboro Quarterly Meeting's discussion of same, a 1996 minute by our Meeting on the topic, and steps toward healing that have already been taken.

**Peace & Social Concerns**--Beginning in June, the book discussion group will reconvene. It will meet on the second and fourth Sundays, 8:30 a.m., each month.

**Religious Education**--There is a need for volunteers to teach during the summer weeks when the regular program is not in session.

**Hospitality**--Volunteers are needed to provide refreshments after worship.

**Peace Center**--The recently completed Mission Statement was distributed.

## Torture Awareness Month

The National Religious Campaign Against Torture (NRCAT) has declared June 2008 "Torture Awareness Month" and launched a "Banners Across America" project for the month. The "Torture Is Wrong" banner has been displayed at the meetinghouse for nearly a year now. We believe our government continues to permit CIA and military interrogators to use torture. The Peace & Social Concerns Committee will provide the Meeting with current information about what's happening in Congress, in the Supreme Court, and the Military Commission hearings at Guantanamo.

Do you know there are 50 detainees who will not be brought up before the military court but are not being repatriated because the U.S. government believes they would be tortured in their countries (such as China, Libya, Tunisia, Algeria)? Did you read or hear that a former detainee recently testified in a hearing of the House Foreign Affairs Subcommittee on International Organizations, Human Rights and Oversight? Do you know about the 35 activists to be tried for their protest before the Supreme Court on January 18 (6th anniversary of the arrival in Guantanamo of the first "detainees" from Afghanistan)? Have you heard any promises to end torture by any of the candidates for President or Congress? For the first two questions, go to the web site for the Center for Constitutional Rights (<http://ccrjustice.org/>), for the third question, read "Guantanamo's Day in Court," ([http://www.boston.com/bostonglobe/editorial\\_opinion/oped/articles/2008/05/26/guantanamos\\_day\\_in\\_court/](http://www.boston.com/bostonglobe/editorial_opinion/oped/articles/2008/05/26/guantanamos_day_in_court/)), an essay by James Carroll in the May 26 edition of the *Boston Globe*. The fourth question is for each of us to find out!

(NRCAT) has also provided the following prayer for use in June by faith communities across the nation as part of their effort to bring an end to torture:

*Dear God of Many Names, at the heart of our longing, there is a cry for compassion. In the midst of war, as we work and pray for peace, all the world's people must nourish a kernel of compassion from which a true and lasting peace may grow.*

*Mighty God, as you have stood with the saints, sages, and prophets of the world's great traditions, as you have stood with our ancestors who have cried, "Peace, Peace," when there was no peace, we pray to feel your strength and presence. We honor your name when we courageously speak out against those actions that harm the soul of our nation, none more than the torture of body, mind, and spirit of one human being at the hands of another.*

*We hold in our hearts those who have been tortured. Their suffering will not be forgotten or silenced so long as we give voice to their plight.*

*We hold in our hearts those who have engaged in torture and pray they will take up the powerful path of redemption. May they cease and desist and turn away from this path that corrupts their souls.*

*And for those who would sully our nation's name out of fear, our hopeful prayers envision a new day, when leaders will find strength in the power of compassion and peace.*

*By our prayers and actions, may we attain forgiveness for what we have allowed to occur in our name. May we be worthy to do good deeds in your eyes.*

*And let us say, Amen.*

A huge portion, about 95 percent, of what the U.S. spends to engage with the rest of the world is allocated to the military budget. A tiny amount, about five percent, is devoted to diplomacy, development, and supporting international institutions that can help to solve problems before they turn into deadly conflict. To ask candidates: Will you support the U.S. paying its full share of United Nations dues and commit to increasing funding for the State Department and U.S. Agency for International Development?

### **Monthly Meeting approves a budget for 2008-09**

On May 18, Monthly Meeting approved a budget of \$15,600 for the coming fiscal year, which begins on June 1. This represents a reduction of \$1,750 both in projected income and budgeted expense, from the budget approved a year ago. Although income fell short of target in 2007-08, the targets set a year ago may have been a little optimistic, since actual income for the year about to end is expected to be very close to the amount actually received in 2006-07. This is a welcome development, indicating that the decline in contributions that the Meeting has been experiencing for several years may be coming to an end.

On the spending side, we expect to almost break even against income in 2007-08, although at levels considerably lower than were budgeted for the year. As a result, the budget approved by Monthly Meeting for 2008-09 shows some reductions, most particularly in the area of committee expenditures, where several committees have left sizeable portions of their allocations unspent. Each committee (with the exception of First Day School, which has its own source of funding from outside the regular budget) will have at least as much to spend as it actually spent in 2007-08, and in several cases will have more. Contributions to Quaker bodies, like New England Yearly Meeting, will remain unchanged, but there will be a reduction in allocations made by the Meeting as a whole to community activities in the Damariscotta area. (In discussing this, Monthly Meeting gave serious consideration to instituting weekly collections, where Friends could make personal donations, through the Meeting, to local charities.) The largest part of the budget remains the operating expenses required to run the meetinghouse, and these are under inflationary pressure. Hopefully the planned installation of solar panels, as well as other conservation measures, will help to offset the rise in energy prices, but the Meeting, as will we all individually, will need to keep a very close eye on rising costs in the coming year and beyond.

The Finance Committee will be circulating pledge letters in the coming weeks, and it is hoped that Friends will be generous in their responses, so as to help foster the vitality of our precious resource.
