Clerk Carmen Lavertu opened the meeting with a brief silence. There were 15 people present. The minutes of the previous meeting were read and approved with minor corrections.

## **Treasurer**

Paul Diamond gave an excellent two-part report detailing first our outflows for the period from June 1st through September 20th and then giving a summary of our financial position to date. Very few of our budgeted amounts have been spent in the first quarter, but that is typical of first-quarter activity in prior years. The amount of pledges received is not yet equal to last year, reminders will be sent out this fall. Friends expressed appreciation for Paul's clear report.

## **Finance Committee**

Bill Spock reported for the committee, which will meet again on October 3rd. They welcome comments or questions from members of the Meeting community. The committee projects that there will be no surplus for the coming year.

## **Ministry & Counsel**

Charlotte Ritter reported the committee is planning a report on members and attenders. The committee addressed the suggestion by a member that we have a special committee to look after the needs of elder members. It was decided that a separate committee was not required and that Ministry & Counsel would continue to focus on this area. A Memorial Minute is being drafted for Cully Miller.

Peter Albright has written to the Meeting seeking to transfer his membership to Crystal Lakes Meeting in Illinois, where he has been living for some time. The request was approved, and a letter will be sent to Crystal Lakes Meeting.

Concern has been expressed for the Wabenaki Program Committee. Charlotte Ritter asks that we hold them in the Light.

Friendly 8's dinner gatherings need to be organized for the fall and winter months. Barbara Foust volunteered to take on this assignment.

## **Peace and Social Concerns**

Ernie Foust announced two upcoming programs worthy of the Meeting's attention. AFSC is sponsoring an Alternatives to Militarism for Youth in Maine program at Bates College on November 9th. Pamphlets are available and the committee is willing to sponsor people, especially youth, educators, and parents who want to attend. The Friends World Committee for Consultation (FWCC) is holding a program called "Peace Witness in a Time of Crisis: A Friend's Consultation" on January 17 through the 20th at Guilford College in North Carolina. Each Yearly Meeting is being asked to send 3 or 4 people. In order to be considered for one of NEYM's sponsored positions, a letter of intent needs to be submitted to FWCC committee of NEYM by October 5th.

Andy Burt discussed a proposed Middle Eastern Dinner which the Meeting would sponsor jointly with the Midcoast Unitarian Universalists and Beth Israel Congregation as a fund raiser for the Seeds of Peace Camp. The event would probably be held in January or February. The 2nd Congregational Church in Newcastle or St. Philips in Wiscasset is being considered a venue because both have excellent kitchen and dining facilities. Support was expressed for this interfaith project. Andy will continue preliminary planning. Ernie Foust read a draft of a letter which we might want to send as a meeting to our political representatives in Washington. There was much discussion, and ultimately it was decided that we should write individual letters due to the urgency of the situation, the difficulty in preparing a corporate letter under the pressure of time, and the fact that the number of contacts is often a critical factor in getting the attention of our leaders.

## **Landscape Committee**

Pat Spock reported that the committee has fallen behind with its work this year, and that it might be prudent to get some professional help from a landscaping company. She has requested a number of specific bids and will report the results.

### Old Business

The benefit yard sale for Ramallah School was a great success both financially and energetically! The Meeting raised \$3668, and there may still be more monies coming in. The organizing committee—Claire Darrow, Deb Haviland, Jean Crawford, and Nancy Booth—did a wonderful job bringing this together, and Jean calculated that 39 members of the Meeting community had participated in some fashion. Jim Matlack of the AFSC heightened our awareness of the Palestinian issues in his excellent talk on August 4th. We thank Jim for his time and his insights.

### Worthy Needs

Jean Crawford gave the final recommendations for charitable giving from the ad hoc Worthy Needs committee. A total of \$1600 was allotted for charitable giving this fiscal year. Ten organizations were chosen for gifts ranging from \$100 to \$250, based on a list of 10 criteria which were clearly defined and expressed in the report. The report was approved.

### New Neighbors—Potluck Supper with Mormons

The Church of Latter Day Saints has responded to our welcome invitation, and they have suggested that a potluck dinner be held on October 19th. This is a Saturday and though some members expressed concern that it is wedged between our last Friday business meeting and Sunday Meeting for Worship, others noted that there have been several delays already and said we should not put it off any further. It was agreed. The event will be held at the meetinghouse.

## Friends to Friends in Ramallah

Almost \$4000 is being sent to the Ramallah Friends Schools in Palestine, the proceeds of last weekend's barn sale held by the Midcoast Meeting of Friends (Quakers) in Damariscotta. New friends of the Ramallah School include donors and buyers from here and afar, brought together by the fine weather and the search for treasures. The money generated will be used in part to repair the damage caused by an errant bomb last December, in part to support programs of the kindergarten through grade 12 schools.

The Ramallah School was the focus of national attention this past weekend when world-famous Israeli pianist Daniel Barenboim defied a ban on visiting the West Bank, slipping through a military checkpoint to bring music to the Ramallah students. The students were impressed both by his efforts and by his lack of guns. Violence has temporarily closed their school several times during the last school year.

The Ramallah School, occupying two campuses about 10 miles north of Jerusalem, shares its philosophy of peace and non-violent conflict resolution with more than 900 students with Moslem, Christian, and Jewish backgrounds. Although the school is governed by local boards, it has been administered by the Friends United Meeting of Quakers for over 100 years.

# Rob Patterson Opens Law Practice

Dear Friends:

I would like you all to know about my new law practice based in Camden and ask for your support in spreading the word to people who you think might appreciate my orientation. My goal is to develop a holistic approach to problem solving and advocacy—to practice law as a healing profession. Sound oxymoronic? “Lawyers” and “healing” in the same sentence? There is a small but growing initiative to find ways to make the legal system more humane and outcomes more restorative and less punitive. My own experience in matters of family law plus my earlier practice in Washington, DC, convinced me that the law as often practiced is a corruption of very noble intentions.

Though my work will, initially, be fairly broad in scope, simply because of the time it takes to develop a specialty practice, my focus will be toward so-called “Elder Law” issues such as Medicaid eligibility and estate recovery, long-term care insurance, wills, trusts, powers of attorney, guardianship and conservatorship, and probate of estates. The demographic reality is that an ever-increasing number of us are facing issues concerning our own aging and that of loved ones, which involve both legal complexity and personal challenge. People need more than a correct interpretation of the law, they need a compassionate and ethical ally.

## Sign Up for Freedom

Alternatives to Militarism for Youth in Maine

Saturday, November 9th, 9 a.m. to 4 p.m.

Chase Hall, Bates College, Lewiston, Maine

In the face of increased pressure by military recruiters, high school students face important choices and need to hear about alternatives to violence. The goals for this conference according to the promotional brochure are “to inspire youth to take greater control of their lives and to take action for a more nonviolent world, to reduce fears that young people have about our violent world, and to encourage them to find and practice nonviolent alternatives.”

The keynote speaker will be Kevin Ramirez, program coordinator of the Military in Our Schools Program of the Central Committee for Conscientious Objectors (CCCO) in Philadelphia. This program counters military recruitment in high schools by presenting information on the realities of military life and gives students information on conscientious objection.

This conference is a first event being sponsored by the new American Friends Service Committee (AFSC) Peace and Justice Clearness Committee in Maine. Co-sponsors include Veterans for Peace, Maine Council, the Department of Philosophy and Religion of Bates College, and Maine draft and military counselors.
